# ITN Initial Training Networks

Networks of at least 3 organisations (industry and SME included) from different countries engaged in research training. The networks will be built on a joint research training programme for Early stage researchers. Possibility for recruitment of Experienced researchers.

**Funds**: Living, mobility allowance for the researchers + contribution to the institution for research activities (1800 Euro/month/researcher) + contribution to management and overheads.

Deadline: 22 November 2012



## ITN - EID

#### **Initial Training Networks – European Industrial Doctorates**

Networks of 2 organisations: One industrial partner and one academic institution from different countries engaged in a jointly supervised doctoral programme for Early Stage Researchers. Possibility for associated partners to be part of the doctoral training programme.

**Funds**: Living, mobility allowance for the researchers + contribution to the institution for research activities (1200 Euro/month/researcher) + contribution to management and overheads.

Deadline: 22 November 2012



### ITN - IDP

#### **Initial Training Networks – Innovative Doctoral Programmes**

Sole academic participant (able to provide a PhD) aiming at providing an iterdisciplinary, international and intersectoral doctoral programme, in collaboration with a wide set of academic and industrial associated partners.

**Funds**: Living, mobility allowance for the researchers + contribution to the institution for research activities (1200 Euro/month/researcher) + contribution to management and overheads.

Deadline: 22 November 2012



## COFUND

Co-funding of regional, national and international programmes

The co-funding action aims to encourage existing or new regional and national programmes to open up to and provide for trans-national mobility, as well as to reinforce international programmes.

**Funds**: 40% of the fellowships costs.

Deadline: 5 December 2012



### IAPP

#### Industry-Academia Partnerships and Pathways

Joint research programme between one or more research organisations and one or more commercial enterprises. The activities will consist of secondments between the two sectors, recruitments of new staff and organisation of joint events.

**Funds**: Living, mobility allowance for the seconded and recruited researchers + contribution to the institution for research activities (1800 Euro/month/researcher) + contribution to management and overheads.

Deadline: 16 January 2013

### International Research Staff Exchange Scheme

Staff exchanges and networking activities between European research organisations and organisations from the following countries:

 Countries with EU International agreements on Science and Technology: Algeria\*, Argentina\*, Australia, Brazil\*, Canada, China\*<sup>82</sup>, Chile\*, Egypt\*, India\*, Japan, Jordan\*, Rep. of Korea, Mexico\*, Morocco,\* New Zealand, Russia\*, South Africa\*, Tunisia\*, Ukraine\*, United States.
 Countries of the European Neighbourhood Policy (ENP):

 Eastern Partnership Countries: Armenia\*, Azerbaijan\*, Belarus\*, Georgia\*, Moldova\*<sup>83</sup>, Ukraine\*<sup>83</sup>.
 and
 Mediterranean Partnership Countries (MPC) that are not associated countries: Algeria\*, Egypt\*, Jordan\*, Lebanon\*, Libya\*, Morocco\*, Palestinianadministrated areas\*, Syrian Arab Rep.\*, Tunisia\*.

International Cooperation Partner Countries (ICPC) eligible for funding in IRSES

**Funds**: Subsistence allowance of the outgoing European researchers of 1900 Euro per researcher/month (plus 200 Euro per researcher/month exchanges to countries far from the EU). **Deadline**: 17 January 2013

## **Career Integration Grants**

This action consists of financial support for between 24 and 48 months (full time equivalent) for professional career integration projects in a host organisation in a Member State or associated country.

**Funds**: Lump sum of 25.000 Euro per year up to a max. of 4 years.

**Deadlines**: 7 March & 18 September 2013

# Intra European Fellowships

To support the career development of experienced researchers at different stages of their careers, and seeks to enhance their individual competence diversification in terms of skill acquisition at multi- or interdisciplinary level and/or by undertaking intersectorial experiences.

**Funds**: Living, mobility and travel allowance for the researchers + contribution to the institution for research activities (800 Euro/month/researcher) + contribution to management and overheads.

Deadline: 14 August 2013



## IIF

# International Incoming Fellowships

For third country researchers to come in an European Institution for max. 2 years and with a possible return phase of 1 year in the third country (if ICPC).

**Funds**: Living, mobility and travel allowance for the researchers + contribution to the institution for research activities (800 Euro/month/researcher) + contribution to management and overheads.

Deadline: 14 August 2013



## IOF International Outgoing Fellowships

For experienced researchers working in Europe to go in third country institution for max. 2 years and with a compulsory return phase of 1 year in the European Institution.

**Funds**: Living, mobility and travel allowance for the researchers + contribution to the institution for research activities (800 Euro/month/researcher) + contribution to management and overheads.

Deadline: 14 August 2013
